- Boosts long-term sustainability, especially in the first 2 years

3. Stages of Entrepreneurial Accompaniment in Algeria

Stage	Description
Reception (الاستقبال)	Initial orientation, needs assessment, and introductory consultation.
Project Development (مرحلة الإنشاء)	Assistance in building a business plan, legal setup, and financial projections
Post-Creation Monitoring (المتابعة بعد النشأة)	Regular support on treasury management, customer acquisition, and contracts
Autonomy Building (الاستقلالية)	Enhancing self-learning, decision-making, and independent leadership skills

Type	Purpose
Moral Accompaniment (معنوية)	Clarifies ideas, strategy, and builds confidence

Financial (مالية)	Provides help with funding sources, tax exemptions, grants, and guarantees
